### **COMMUNITY PROFILE**

Rural Community of Upper Miramichi is known as the "Geographical Center of New Brunswick". Upper Miramichi consists of 16 communities along the Southwest Miramichi River. It is centrally located to travel to Fredericton in the south and Miramichi City in the north. Current population according to 2021 Census is 2,075.

The Rural Community of Upper Miramichi has invested heavily in the Community Park. It has walking trails, tennis court / rink with a new covered structure, splashpad with one of only 3 largest buckets to date in New Brunswick, playground equipment, outdoor fitness equipment and a gazebo for entertaining.

The departments include Administration, Protective Services and Recreation Services.

### **COMMUNITY COUNCIL**

The Community Council consists of a Mayor, Deputy Mayor and 3 Councillors, elected every four years. Election 2021 was held in May. All Council members were sworn in under acclamation.

### **Council Meetings**

All regular Council meetings are held at the Upper Miramichi Community Centre located at 6094 Route 8 in Boiestown. All regular, special and committee meetings are open to the public. They are held on the fourth Monday of each month. Special meetings are held periodically to deal with matters that Council deems urgent.

Refer to Appendix 1 for the types, dates of meetings and member attendance.

### PROPERTY TAX RATE

The tax base for Upper Miramichi in 2021 was \$116,198,400 and the residential property tax rate was \$1.1042. This rate includes the Municipal rate, the Provincial rate and the Local Service District rate. The LSD rate covers the policing services. A homeowner with a property assessed at \$70,000 paid \$772.94.

### GRANTS FOR SOCIAL OR ENVIRONMENTAL PURPOSES

One of the purposes of a local government as stated in the *Local Governance Act* is to foster the economic, social and environmental well-being of its community. In 2021, Upper Miramichi gave out \$16,000 in grants to local organizations.

The following are the organizations who received grants in 2021:

- 1. Astle Recreation Center \$500.00 Funding towards repairs to building.
- 2. Cameron Hill Cementary \$500.00 Funding towards topsoil for graves.
- 3. Central NB Woodmen's Museum \$9000.00 Funding towards the renovation project to building and electrical system.
- 4. Upper Miramichi Firearms Club \$500.00 Funding towards upgrades to range.
- 5. Landmark Lodge \$500.00 Funding towards repairs to building.
- 6. McNamee Recreation Council \$500.00 Funding for repairs to entrance of building.
- 7. Belyea Loyal Orange Lodge # 148 \$500.00 Funding towards wheelchair ramp.
- 8. Boiestown / Doaktown Minor Hockey \$3000.00 Funding towards the Minor Hockey program.
- 9. Village of Doaktown \$1,000.00 Sponsorship at Prospect Place Arena.

# **SERVICES**

Local government budgets and services are established in accordance with a standardized classification system. Council adopted a general operating budget of \$812,544 in 2021. Actual revenues were \$1,072,333 as there were higher than expected non-tax revenues. Also, the Village of Doaktown and Upper Miramichi have entered into a joint contract for Garbage and Recycling collection and disposal. The Village of Doaktown reimburses Upper Miramichi for their share. This is reflected in the increase in revenues. The expense is reflected in Upper Miramichi environmental health services. Actual expenditures were \$1,069,710. This enabled RCUM to put money into the General Capital Reserve Fund to pay for future infrastructure costs.

### **GENERAL SERVICES**

Total expenditures \$1,044,715

### **General Government Services**

Total expenditures \$339,639

This category includes administration costs of Mayor and Councillors - \$49,374: administration - \$207,044; auditing fees - \$9,650; grants to local organizations - \$16,000; public liability insurance - \$15,933: regional services - \$2,612; Community development - \$17,484; interest and bank charges - \$10,728 and the cost of assessment of properties within the boundaries of RCUM - \$22,542.

### **Protective Services**

Total expenditures \$135,748

Protective services include fire protection, emergency measures and animal control.

The Upper Miramichi Fire Department provides protective services to the Local Service District of Stanley and has Mutual Aid agreements with Stanley, Doaktown and Blackville. The Department has a Fire Chief and 24 volunteer firefighters. The LSD of Stanley pays approximately 20% of the operating cost. Total expenditures for 2021 was \$133,486

The UMFD has two fire halls, one in Boiestown and one in Bloomfield. One fire tanker is housed at the Bloomfield fire hall. UMFD purchased a new tanker in 2017. The Department is equipped with a total of 3 tankers, 1 rescue vehicle, 1 pickup, 1 four-wheeler with tracks, 1 enclosed trailer, 1 rescue sled, one motorboat and trailer and fully equipped fire halls.

Animal control services are provided by RCUM. One animal control officer is on duty. Total expenditures for 2021 was \$1,903.

Emergency Measures has a Committee in place to develop a working plan for RCUM. Total expenditures for 2021 was \$359.

### **Environmental Health Services**

Total expenditures \$283,765

This category includes the cost of garbage and recycling collection and disposal. Joe's Garbage Pick-up Ltd. collects the waste at a cost of \$195,315 for 2021. Waste is disposed of at Red Pines Sanitary Landfill in Allardville, NB. Greater Miramichi Solid Waste looks after billing and the cost for 2021 was \$88,450. The tipping fee for residents was \$90.40 for garbage and the tipping fee for recycling was \$40.00.

### **Environmental Development Services**

Total expenditures \$42,747

This category includes land use planning services provided by the Greater Miramichi Service Commission at a cost of \$32,539.

Other community projects costs were \$2,470.

The Business Park is also included in this section. The total cost for 2021 was \$3,412.

Tourism costs was \$4,326.

### **Recreation and Cultural Services**

Total expenditures \$67,545

This category includes the MOU with the Upper Miramichi Community Library which cost \$19,000 for 2021.

Also, included is Exhibitions and Fairs which provides free events to citizens. Cost for 2021 was \$4599.

The Upper Miramichi Community Park cost for 2021 was \$20,936. These costs include upkeep and maintenance for the park.

### **Public Health Services**

Total expenditures \$1,543

This category is for maintenance of the Community Vault. Total cost for 2021 was \$1,543.

### **Fiscal Services**

Total expenditures \$173,728.

The Federal Government provided a one-time Covid-19 relief funds of \$120,406. Council made a motion to apply \$115,000 of these funds to pay for the remaining amount owing on the Community Center.

This category includes the interest on long-term loans, principal repayment of long-term debt and bank charges.

2021 cost of long-term debt was \$10,089.

2021 cost of principal repayment was \$163,000.

2021 cost of bank charges was \$639.
